Kansas Department of Children and Families launched the Mobile Crisis Helpline for additional support for eligible Kansans in need during a crisis.

Services are available for ALL Kansans 20 years old or younger, including anyone in foster care or formerly in foster care, though this service is not limited to children and youth in foster care.

Available resources include:

- Over the phone support and problem solving to help resolve a child's behavioral health crisis

- Over the phone support with referral to community resources or a recommendation to engage in stabilization services
- In-person support via mobile crisis response if the crisis cannot be resolved over the phone

·In emergency situations, EMS, law enforcement and/or the mobile crisis response unit will be contacted to assist

The Kansas Mobile Crisis Helpline is a public service number for use by all Kansans and is not limited to professionals of any kind.
