Privacy Policy

Kansas Legal Services is committed to protecting your privacy and safeguarding any personal information shared with us. This Privacy Policy outlines how we collect, use, and protect the information provided through our website and other communication channels.

Information Collection

We collect only the necessary information to provide our legal services and to communicate with you effectively. This may include your name, phone number, email address, and other contact information. We do not sell, rent, or share your information with third parties.

Kansas Legal Services uses tools, including Google Analytics, to collect web traffic data and other statistics to monitor and improve the performance of our website. Google Analytics collects information such as device details, browser type, IP address (which may be anonymized), and user interactions on the site (e.g., pages visited, links clicked). This data helps us understand how users engage with our website, which pages are of most interest, and to enhance the user experience. The data collected is not linked to personally identifiable information.

The website uses "cookies," which are small text files placed on your computer's hard drive. These cookies help us track web traffic and monitor user behavior, such as the number of visits to various pages. Cookies related to Google Analytics may collect additional information such as device information, geographic location, and browsing patterns. You may disable cookies through your web browser settings, though this may affect the functionality of certain website features. Kansas Legal Services uses cookies only to remember login names for registered users and to track website performance through analytics. We do not use cookies to collect any unrelated information.

While Kansas Legal Services does not share your personal information with third parties, Google, as a service provider, may have access to some of the anonymized or aggregated data collected through Google Analytics. We cannot guarantee that third parties will not circumvent our security measures, potentially resulting in a data breach. However, we take reasonable precautions to protect your information.

How We Use Your Information

The information collected is used exclusively to provide legal services, answer your inquiries, and keep you updated about relevant information regarding our services. We do not share your information with third parties, except as required by law or as part of providing our services.

Your Choices

You have the right to request access, correction, or deletion of your personal information at any time. If you have concerns or questions regarding the use of your information, please contact us.
